To consider and approve the Separate Audit Report 2023 of Shri Lal Bahadur Shastri National Sanskrit University.

The Finance Committee discussed the Separate Audit Report 2023 issued by the Office of the Director General of Audit, Central Expenditure; New Delhi on the Annual Accounts 2022-23 of Shri Lal Bahadur Shastri National Sanskrit University. Finance Committee appreciated the good working of University as could revealed in the SAR issued by Audit Department. After a detailed discussion, the Finance Committee Resolved to approve the Separate Audit Report 2023. Further, since the Audit Report alongwith Annual Accounts 2022-23 is to be forwarded to the Ministry of Education within a stipulated time-frame, the Finance Committee Resolved to confirm the agenda as table confirmation item and recommended the same to Executive Council for approval.

To consider and approve the enhancement in TA rate of the staff members of Faculty of Education deputed on teaching practice.

The Finance Committee noted that a Committee was constituted by Hon'ble Vice-Chancellor for the purpose of examining for rationalizing the rate of conveyance charges for payment to Teaching and Non-Teaching staff members of Faculty of Education of the University, deputed on teaching practice. The agenda was claborated by the Member Secretary and it was informed that the Teaching and Non-Teaching staff members who are deputed on teaching practice, also use to come to the University. The Finance Committee took a note that if the local conveyance charges are paid as per TA Rules of Government of India, the same may amount to heavy financial burden on the University. Thereafter, the Finance Committee emphasized that the payment should strictly be on actual attendance and prorate basis duly certified by Dean of Faculty of

Further, since the entitlement for local conveyance payment of Non-Teaching staff members is usually less than the. Teaching staff members, hence monthly payment rate of local conveyance charges of Non-Teaching staff members should also be lesser than the Teaching staff members.

Accordingly, after a detailed discussion, the Finance Committee Resolved to accept the local conveyance charges of Rs. 4.50% per month to the Teaching staff members and Rs. 3,00% per month to the Non-Teaching staff members, deputed on teaching practice subject to the condition mentioned in the preceding paragraph and recommended the same to Executive Council for approval.

To consider and approve the proposal for suction of obsolete IT Equipment and peripherals of the University through GeM.

The Finance Committee discussed the proposal for auction of obsolete IT equipment and peripherals of the University through GzM. The Finance Committee also perused the guidelines contained in the letter No. 8-11/2012-13/IT-1 dated 26.12.2014 issued by Informat.on Technology Cell, Department of Telecommunications, Ministry of Communications & IT, Government of India duly communicated by S&S Section, Department of Higher Education, Ministry of Education, Government of India vide letter No. F.No. 29-6/2018-S&S datec 25.11.2022 enclosed with the agenda. The list of the condemned items was also discussed and it was observed that the items were mostly 8-20 years old. The items have outlived their designated life and have become obsolete, occupying the large storage space of the University.

After a detailed discussion, the Finance Committee Repolved to accept the auction of obsolete IT equipment and peripherals of the University through GeM and recommended the same to Executive Courcil for approval.

ITEM NO. 7.4.4

To consider and adopt the payment of Gratuity Act, 1972 administered by Ministry of Labour & Employment, Government of India for employees covered under NPS.

The Finance Committee perused the letter No. Nil dated 27th January, 2022 received from Govt. of India, Ministry of Education, Department of Higher Education, Integrated Finance Division. The Finance Committee also noted the letter No. F.No.15-2/2022-TC dated 1st December, 2023 provided by the Integrated Finance Division alongwith the comments on agenda of the meeting. The Finance Committee Resolved to adopt the payment of Gratuity Act, 1972 administered by Ministry of Labour and Employment, Govt, of India for employees of the University, covered under NPS and recommended the same to Executive Council for approval.

The Finance Committee also noted the guidelines of the University Grants Commission with respect to creation of Alumni Endowment Fund, vide 'etter No. F.3-1/2019 (CU) dated 8th August, 2013. Accordingly, considering the NAAC accreditation of the Jniversity is also under process, Finance Committee Resolved to accept the proposal for transfer an initial seed money of Rs. 2,51,000/- to Alumni Association Fund, from long pending unclaimed money lying under Student Library Security Deposit and recommended the same to Executive Council for approval.
