

## **Terms and Conditions**

*(for procurement of CCTV Camera in the Vidyapeetha through GeM)*

1. The network for CCTV setup considered in this bid is for 57 cameras including all required hardware items excluding 36 cameras, the bidder must ensure the functioning of all 57 points/locations of the cameras.
2. The bidder must inspect the existing CCTV system and include the cost of all the mandatory items like SFP Module, Fiber Patch Cord, LIU, Patch Panel, Fiber Splicing and other hardware or software required to make the project operational.
3. Supplied system must be integrated with our existing analog CCTV system ( 04 PTZ & 04 Bullet )
4. Site inspection letter for setup of CCTV camera in the Vidyapeetha should be submitted.
5. All technical specification must be complied; no deviations will be accepted.
6. Manufacturer authorization letter for this tender specific and end of life certificate (should not be less than 5 years) from the OEM for all major product i.e. NVR / Camera should be enclosed.
7. Bidder must ensure to monitoring the view of CCTV cameras at min. 6 different locations of Vidyapeetha.
8. On-site comprehensive 5 Years warranty of all products along with software and accessories.
9. Undertaking for Five years' warranty and after sales support from OEM and Bidder both is required
10. Warranty period will be start after the successfully installation of the entire system.
11. Successful Bidder has to deposit 5% Performance Guarantee of the tender value in the form of DD or FDR within 10 days of acceptance of Lol, for the period mentioned in Bid Document.
12. Complete systematic connectivity diagram should be submitted along with bid on bidders' letter head with stamp and signed.
13. Successful Bidder has to complete the installation and implementation job within 4 weeks after acceptance of order.
14. Bidder must enclose the entire supporting document.

15. Presence of OEM support center in DELHI NCR region mandatory.
16. Any damages to the Vidyapeetha property shall be made good by the agency at its own cost.
17. OEM vetted Technical compliance to the camera and NVR specification should be uploaded on OEM letterhead.
18. OEM should not have been black listed/Barred by ONVIF.
19. Mac id should be registered in the name of manufacturer.
20. Camera and NVR should be of the same make.
21. **BIS** is mandatory by Govt of India. Certificate should be enclosed for proof of same.
22. Any manufacturer claiming make in INDIA is required to submit affidavit to the effect that the products and models offered are manufactured in INDIA as per DPIIT policy and not just assembled and branded in INDIA.
23. Undertaking from Bidder and OEM both for not blacklisted by any Central Govt./State Govt./CPSU in India.
24. Acceptance of all Special terms and conditions must be submitted on bidder's letter head with stamp and signed.
25. The EMD/Bid Security may be forfeited.
  - If a Bidder withdraws his bid during the period of bid validity.
  - In case of successful bidder, if the bidder fails to sign the contract agreement and furnish performance security.
26. The competent authority reserves the right to reject any or the entire bid without assigning any reason, at any stage, and his decision will be final.
