### NOTIFICATION

Pursuant to the letter No. 8-46/2021-L.II dated 15.11.2021 of the Government of India, Ministry of Education, Department of Higher Education, Language Division, a High Powered Committee has been constituted to explore and recommend a pathway for holistic, multi-disciplinary growth for promotion of Indian Languages as envisaged in the National Education Policy-2020 and advise the Ministry on all matters pertaining to revitalization of existing language teaching and research and its extension in various institutions in the country. **The terms of reference is as under:-**

- *Study the existing institutional set up and suggest ways for improvement of study of Indian Languages under school and higher education in the context of the objectives outlined in NEP-2020*
- *Recommend ways to revamp, consolidate and integrate the existing set up to ensure best utilization of existing language teaching facilities in educational institutions for development of Indian Languages*
- *Ensure coverage of all categories of languages, Scheduled, Endangered, Non-Scheduled Minor, Tribal, Classical Languages etc.*
- *Make recommendations for language teaching-learning, language teachers education and growth, research, building language repositories, translation and interpretation, including its bearing on the furtherance of skilling and vocational education*
- *Recommend ways for making available technological tools and labs in various languages for the benefit of students and researchers.*
- *Promote availability and usage of various teaching learning material in different languages for the benefit of learners.*
- *Recommend ways to improve employability of language students as well as ways to improve employment opportunities by learning global languages as a skill*
- *Recommend road-map and hand holding strategies on various measures in respect of Indian languages in view of NEP-2020*
- *Recommend strategies for the promotion and sustenance of Language institutions and make them multi-disciplinary*
- *To closely coordinate with various student centric initiatives of the ministry like Innovation Cell, Indian Knowledge System etc., leading to EK Bharat Shrestha Bharat.*
- *Any other matter bearing direct impact on Indian languages*
- *Submit a Plan of Action regard to the above.*

Accordingly, in order to achieve the above-mentioned objectives of the High Powered Committee within the time bound manner, "Walk-in-Interviews" have been scheduled for interested candidates, who are retired from Central/State Govt., PSUs and Universities, well versed with the aspects of works and have

### Terms & Conditions of engagement:

**Term of Appointment:** These posts are expected to be filled by officers/teachers/researchers etc., retired from Govt. institutions/Universities as mentioned above. However, for posts other than Consultant (Admn & Fin), persons, other than retired who have the requisite PG qualifications/Research and work experience may also apply. However, it is to be noted by such persons that the engagement is purely temporary and will continue only till the services are required by the High Power Committee. Their engagement will not impose any lien or liability to continue or further engage them on anyone. A consultant will be initially engaged for a period of three months or for a period of one year. He will continue subject to performance to the satisfaction and at the pleasure of the Chairman of the High Powered Committee, and the term is extendable by a similar period, keeping in view the requirements of the High Powered Committee, subject to satisfactory performance of the person concerned.

- **Remuneration:-** A fixed remuneration as mentioned above shall be admissible. The remuneration amount shall remain constant throughout the term of the contract. There shall be no annual increment/percentage increase during the contract period.
- **Leave of absence:-** Paid leave of absence may be allowed at the rate of 1 day for each completed month of service. In addition, two Restricted Holidays are allowed as per Central Govt. Rules. Accumulation of leave beyond a calendar year may not be allowed.
- The consultant shall sign an agreement of confidentiality with the Government of India containing a clause on Ethics and Integrity.
- The Consultant shall be ineligible for any other benefits available to regular University employees.



- The Consultant will have no claim for regularisation/seniority on the basis of this engagement. This service is purely temporary.
- The High Powered Committee of the Ministry reserves the right to terminate the engagement at any time, even before the stipulated time. The consultant shall be required to perform the duties of as assigned by the Chairman from time to time during the period of engagement. The complete details of the duties, etc., will be communicated separately along with the offer of engagement.
- The High Powered Committee reserves the right to withdraw this notification at any point of time.
- Any corrigendum/addendum or any other related information relating to recruitment shall be posted on the website "slbsrsv.ac.in" of the University only, for which the candidates are required to be in constant touch with the website of the University.
