NOTIFICATION

The intent of National Education Policy (NEP)-2020 is to encourage academic and vocational integration in order to achieve multidisciplinary education. The NEP also has a special focus on imparting quality education through Open & Distance Learning (ODL) and Online Mode. In order to set out the objectives of NEP-2020, the structure and system of Open & Distance Learning (ODL) & Online mode can play a great role in meeting these requirements cost effectively. It will not only be limited to offering regular graduate and postgraduate programmes, but also be the facilitators in research activities and teaching multidisciplinary and skill-oriented courses. Further, the Internal Quality Assurance Cell (IQAC) of the University in its meeting held in the month of August-2022 also gave its consent for conduct of University courses through Open & Distance Learning and Online mode.

In this regard, the Hon'ble Vice-Chancellor of the University has constituted a Standing Committee in order to explore possibility of conducting University courses through ODL and Online Learning and further exploring the feasibility of revision of existing curriculum of various courses of the University in order to keep pace with current trends of our educational system. 
