- 3. All the students residing in the Vidyapeetha Hostel are requested to vacate the hostel room on early basis. The students are required to lock their rooms properly before leaving the hostel and fill the entry/ exit register of the hostel concerned. The students will be informed regarding situation and opening of Vidyapeetha Hostel in due course of time.
- 4. All the students are strongly advised to return to their homes and take adequate precautions as per guidelines issued by the Govt. of India.
- 5. All common facilities such as Library, Gym, Yoga Centre, Recreation Room, Canteen, etc., in the campus will remain closed till further orders.
- 6. If any stakeholder with travel history to any COVID-19 affected country or in contact with such persons, should inform the Health Care Unit so that they can be monitored and taken care of, if need be.
- 7. All Faculty Members, Officers and Staff shall continue to attend their duties and responsibilities. Routine Office work will remain un-affected during this period.

Kindly note that there has not been any case of COVID-19 in the Vidyapeetha Campus till date and this is only a preventive measure. Further instructions on the start of the academic activity, and when the students have to report back to the campus will be communicated through Vidyapeetha's website. Kindly keep checking the Vidyapeetha's website for any other updates related to this matter.
