OFFICE ORDER

Subject: Declaring "No Vehicle Day' in a week in the premises of Sri Lal Bahadur Shastri National Sanskrit University to protect the environment- reg.

Government of India emphises that efforts needs to be enhanced for decarbonization as well as to bring in Net Zero effort to reduce pollution in the atmosphere to have longer impact for saving the human lives from not getting impacted due to pollution related diseases. In this regard, we at Sri Lal Bahadur Shastri National Sanskrit University may also pitch in with our efforts to reduce air pollution in various manner. One of the option to reduce pollution to assist the government's efforts in decarbonization of the atmosphere is to go for keeping atleast one day in a week as 'Vehicle Free Day'. During that day, all the teaching and non-teaching staff would ensure that they prefer public transport and do not use their personal vehicle so that one day fuel can be saved and also the pollution comes out of the vehicles can be reduced.

- 2. Accordingly, it has been decided, with the approval of the Competent Authority of the University to declare, with immediate effect, every Wednesday to be a 'No Vehicle Day' for the University Campus. All the teaching and non-teaching staff are requested to cooperate by utilising the public transport facilities available including walk as far as possible on all Wednesdays so that the carbon emission in the campus can be reduced considerably which will greatly help the City reduce the air pollution and also enhance the Health of the individuals. However, use of e-vehicles where the emission levels are considerably less can be permitted.
- 3. Engineering Department would constantly measure and monitor the implementation of this and the Security Agency is also instructed to strictly ensure that vehicles are not plied within the University Campus on all Wednesdays throughout the year.
- 4. All the teaching and non-teaching staff are requested to extend their cooperation in reducing air pollution by religiously avoid using their vehicles both two wheelers and four wheelers on all Wednesdays. The benefit we reap out of this small effort would go a long way in keeping our atmosphere neat and clean and enhance the Human Health.
