It was informed to the Committee that the supplementary complaint dated 17.07.2023 was received from X against the Respondent Nos. Y & Z wherein she has alleged against Y & Z and requested to take appropriate action against them.

Before proceeding further in the matter, at the first instance the complaint was forwarded to Ms. Jyoti Rana, Advocate & Member of Internal Complaint Committee for obtaining her comments/views from legal angle whether the said complaint comes under the purview of ICC or not as per the details given in the complaint. Thereafter, a letter was sent to Ms. Jyoti Rana, Member of ICC & Advocate for her comments/views whether the complaint comes under the purview of ICC or not. Accordingly, Ms. Jyoti Rana vide letter dated 20.07.2023 (copy enclosed) while communicating the rule position, had informed that ... in case the complaint is not made within the time limit provided in the said Section-9 of the Act, 2013, the Internal Complaint Committee can collectively take a decision and record the reasons in writing and can extend the time limit not exceeding three months, if the committee is satisfied that the circumstances were such which prevented the complainant from filing the complaint within the said period as mentioned in her letter.

Subsequently, the copies of the both complaints were sent to the respondents Nos. 'Y' and 'Z' on 20.07.2023 (Copies enclosed) with the instructions to file their replies and also attend the meeting of ICC on 02.08.2023 at 11.30 a.m. in the University. The complainant 'X' was also informed vide letter dated 28.7.2023 to attend the meeting on 02.08.2023. In response to this office letter dated 28.07.2023 (Copy enclosed), the complainant 'X' vide email dated 31.7.2023 has informed the following:

“आदरणीय मैम दिनांक 28 जुलाई 2023 को जब मैं विश्वविद्यालय [REDACTED] मेरे द्वारा कंप्लेंट थी उसमें [REDACTED] ने [REDACTED] के सामने अपनी गलती मान कर लिखित में माफी मांगी थी क्या मैम इसके बाद भी मुझे 2 अगस्त को मीटिंग में आना है या नहीं?”

In the above-mentioned email dated 31.7.2023, the Complainant has also forwarded the two attachments indicating the settlement notes dated 28.7.2023 (Copies enclosed) between the Complainant and the Respondents. Accordingly, as per the directions of the Presiding Officer-ICC, the said email dated 31.07.2023 was sent to the Member-ICC -Ms. Jyoti Rana, Advocate for her advice. Consequently, she has informed vide email dated 01.08.2023 (copy enclosed) as under:-

“Regarding the Email I have received and in the capacity of Member, ICC, LBSU and an Advocate, I hereby inform you that in the first ICC Meeting dated 10/07/2023, the Complainant 'X' was informed about the law and procedure and conciliation option she could opt for by the members of ICC, for which she took time. And now if she is ready for the conciliation and the inquiry has also not been initiated yet, then as per the Act conciliation/settlement can be requested in writing only by the complainant and for the same complainant has to come and attend the next meeting”

In view of the above the complainant was again informed to attend the next meeting of ICC on 02.08.2023. Finally, the complainant Ms. 'X' and Respondents- 'Y' & 'Z' appeared before the Internal Complaint Committee on 02.08.2023 at 11.30 a.m. The Respondents Nos. 'Y' & 'Z' have filed their replies before the Internal Complaint Committee on 02.08.2023 (Copies enclosed).

The ICC noted the above-mentioned position of delay in filing of the complaint by the complainant and the committee is of the view that as per Section-9 of the Act, the delay is condoned as the complainant was not aware about the rule position.

In pursuant to their settlement notes dated 28.07.2023, the complainant vide letter dated 02.08.2023 (copy enclosed) has again informed the ICC that she is willing to reconcile the matter on the certain terms and conditions as mentioned in her letter dated 2.8.2023. The same note has been shown to both

Complainant "X" is absent today without any communication to the Presiding Officer of the Committee. Letter dated 'Nil' received through email on 06.06.2024 is marked to the Internal Complaint Committee by the Vice Chancellor on 07.06.2024.

Respondent "Y" is present before the Committee.

One letter is received from the complainant through the Vice-Chancellor on 07.06.2024 seeking exemption from today's appearance but no justified reason is mentioned in the said letter. Complainant is again and again seeking such information which has been duly responded by the committee through e-mail letters to the complainant. But again, the letter that has been received by the committee on 07/06/2024 wherein the complainant has sought same information that has been duly answered and responded by the committee several times in all previous mails to the complainant.

The complainant has also sought exemption on the ground that her submission is still left. But after enquiring from the concerned department, it has come to the knowledge of the committee that the Ph.D submission work of the complainant is almost completed and nothing remains.

Previously meetings of ICC were held on 15/02/2024, 12/04/2024, 03/05/2024, 06/05/2024 and also today on 07/06/2024. Complainant appeared only on 15/02/2024 and since then complainant never appeared before the committee and chose to remain absent for one reason or the other.

From the above said conduct of the complainant, it can be clearly seen that all the acts of the complainant is nothing but delaying tactics.

On the last meeting i.e. on 06/05/2024 also when the complainant was absent no communication was sent by her, but on 07/05/2024 one email from the complainant was received along with one medical document explaining her absence on 06/05/2024. On looking the facts and circumstance and in the interest of justice, the committee did not pass any adverse orders and again sent her 15 days advance notice for today's meeting, but again the complainant chose to remain absent.

Several opportunities had been given to the complainant to attend the meetings but the complainant chose to remain absent and not attending the hearings of the meeting.

In view of the above facts and circumstances and looking at the disinterest of the complainant in pursuing the complaint, this Internal Complaint Committee is of the view to close the complaint of the complainant as per rule.

The meeting was ended with vote of thanks to the Chair.
